Dear IHC Educators,

The In Home Care Support Agency would like to take this opportunity to welcome educators who have recently commenced within the In Home Care program.

Important information

Please remember to keep *Mission*Australia Children's Services up to date with any changes to your availability. Similarly, if a family is requiring more hours, please remind them to contact *In Home Care* Support Agency before booking in with you, because as you will be aware, families would likely be charged an unsubsidised rate if these hours have not been approved by the IHC Support Agency. This is especially important to keep in mind with the July School Holidays fast approaching.

Mandatory Reporting

As early childhood professionals, it is your duty of care to report if you have concerns about a child's safety or welfare. In Tasmania, the definition provided for when you are required to report is; when you suspect or have proof of: 'Any sexual abuse; physical or emotional injury or other abuse, or neglect, to extent that the child has suffered, or is likely to suffer, physical or psychological harm detrimental to the child's wellbeing; or the child's physical or psychological development is in jeopardy'.

Quarterly Family Management Plan (FMP) Review

In line with IHC guidelines, we are endeavouring to review Family Management Plans quarterly to ensure we have the most up to date information regarding families and their IHC needs. This way, we are able to stay on top of place/hour requirements and changes to family circumstances.

All updated FMP's are emailed to Mission Australia Children's Services who will ensure that updated FMP's are forwarded to relevant educators within one week of receipt.

Resources for IHC Educators

Within our monthly newsletters, the IHC Support Agency will be sharing articles and information on topics linked to all areas of child development. This is to help increase knowledge and understanding around the importance of the early years for children's lifelong development and learning. The topic of our May information sheet is around brain development from birth- 3 years.

Operating Hours

A reminder that throughout 2019, the IHC Support agency will continue to operate from 8am-6pm Monday to Friday. We do not operate on Public Holidays or weekends.
